**All-Party Committee on Appointments Act**

The Commissioner of Yukon, by and with the advice and consent of the Legislative Assembly, enacts as follows:

**1** Each Legislative Assembly shall appoint a Standing Committee on Appointments to Major Government Boards and Committees no later than the 10<sup>th</sup> sitting day of that Legislative Assembly following its election.

**Duties of Standing Committee on Appointments to Major Boards and Committees**

**2 (1)** The Standing Committee on Appointments to Major Government Boards and Committees:

**(a)** shall review nominations and recommend appointments to the following major boards and committees:

**(i)** Yukon Development Corporation Board of Directors

**(ii)** Yukon Energy Corporation Board of Directors

**(iii)** Yukon Workers' Compensation Health and Safety Board

**(iv)** Yukon Lottery Commission

**(v)** Yukon Recreation Advisory Council

**(vi)** Arts Advisory Council

**(vii)** Yukon Utilities Board

**(viii)** Yukon Council on the Economy and the Environment; and

**(ix)** Yukon Human Rights Commission;

**(b)** shall review other appointments proposed by the Executive Council that are referred to it by the Executive Council; and

**(c)** shall meet in camera; and

**(d)** shall prepare a report within 45 days of receipt of a proposed appointment or of proposed appointments and such report shall contain the appointment or list of appointments recommended by the Committee.

**2 (2)** The Chair of the Standing Committee on Appointments to Major Government Boards and Committees shall present all reports of the Committee to the Legislative Assembly and when the Legislative Assembly is not sitting at the time a report has been agreed to by the Committee, the Chair shall transmit the report to all Members of the Legislative Assembly before releasing the report publicly.

### **Power to Make Appointments Prior to Committee Meeting**

**3** When the Commissioner in Executive Council or, if applicable, a Minister, due to legal requirements or operational needs, has deemed it necessary to make an appointment prior to the expiration of the 45 day period, the Committee shall be notified in writing within 14 days, by the Executive Council Office, of appointments made by a Minister or by the Commissioner in Executive Council.

### **Composition of the Committee**

**4** The Standing Committee on Appointments to Major Government Boards and Committees shall consist of three members from the government caucus, one member from the Official Opposition caucus and one member from the Third Party.

### **Coming into Force**

**5** This Act comes into force on a day to be fixed by the Commissioner in Executive Council.
